RESOLUTION TO AMEND BUDGET

**RESOLUTION OF THE ANTELOPE HEIGHTS METROPOLITAN DISTRICT TO
AMEND THE 2022 BUDGET**

Pursuant to Section 29-1-109, C.R.S., the Board of Antelope Heights Metropolitan District (the “**District**”), hereby certifies that a special meeting of the Board of Directors of the District, was held on November 1, 2022 via teleconference.

A. At such meeting, the Board of Directors of the District adopted that certain Resolution No. 2021-11-02 to Adopt Budget appropriating funds for the fiscal year 2022 as follows:

General Fund	\$ 65,000
Debt Service Fund	\$823,055

B. The necessity has arisen for additional General and Debt Service Fund appropriations requiring the expenditure of funds in excess of those appropriated for the fiscal year 2022.

C. The source and amount of revenues for such expenditures, the purposes for which such revenues are being appropriated, and the fund(s) which shall make such supplemental expenditures are described on **Exhibit A**, attached hereto and incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Antelope Heights Metropolitan District shall and hereby does amend the budget for the fiscal year 2022 as follows:

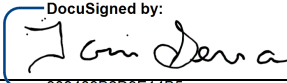
General Fund	\$ 70,000
Debt Service Fund	\$870,000

BE IT FURTHER RESOLVED, that such sum is hereby appropriated from unexpected revenues available to the District to the General Fund and Debt Service Fund for the purpose stated.
